## SERVCORP UNDERLYING PROFIT UP 18% YEAR ON YEAR – GUIDANCE ACHIEVED

## UNDERLYING FREE CASH UP 18% YEAR ON YEAR – GUIDANCE ACHIEVED

Servcorp Limited ABN 97 089 222 506 (SRV) today announced a net profit before non-cash impairments and tax (NPBIT) of \$56.6 million for the 12 months ended 30 June 2024. Market guidance of between \$50.0 million and \$55.0 million NPBIT and underlying free cash of at least \$70 million were successfully achieved.

### Summary of results for Financial Year 2024

- Underlying NPBIT of \$56.6 million, up 18%
- Underlying free cash of \$72.5 million, up 18%
- Revenue and other income \$317.0 million, up 7%.
- Statutory net profit before tax of \$42.9 million, up 153%
- Cash and investment balances currently in excess of \$120.0 million
- Final dividend of 13.0 cents per share, 20% franked; payable on 2 October 2024
- Total dividends for the 2024 financial year of 25.0 cents per share, up 14%
- Dividends for the 2025 financial year are expected to be not less than 26.0 cents per share

### Middle East update

The Middle East reorganisation has been completed to establish the Servcorp Middle East Group. All other work streams are progressing on schedule for a potential listing in 2025.
